# **Dairy Goat Schedule**

Conditions of entry:

Payment must be made at the time of entry. Failure to make payment will mean your entry will not be processed. Entries close on Friday 17th January 2025. Late entries may be accepted after this date; however, a \$20 late entry fee will apply. Any changes to entries after processing will incur a \$10 administration fee.

No late entries will be accepted after Wednesday 29th January 2025; however, the Secretary's Office at the showgrounds will be open for a short period on Thursday & Friday for any last-minute entries or changes.

Judging will be held outside the Garden Shed at 10am. Female animals will be penned in the Garden Shed All male animals over 12 months old will be penned/tethered outside the Garden Shed at all times. Stewards - Willie Solomon Judge - **Gabrielle Hutcheon** Convenor - Donna Morton

ENTRY FEE: MEMBERS \$8.00 NON-MEMBERS \$10.00

PRIZE MONEY: 1-4 Entries - 1st \$15, 2nd \$10 - Ribbons will be given to all place-getters

5 or more entries - 1st \$20, 2nd \$15, 3rd \$10 unless in a special sponsored class where prize money is listed.

Rules and regulations with regard to dairy goats;

- 1. All entries must be made in the name of the bonafide owner, full name and registered number given at the time of entry.
- 2. The date of birth of all goats must be entered on the entry form and the age is deemed to be that of the goat on the first day of the show.
- 3. All classes for the in-milk does are to be judged first.
- 4. All goats entered in special classes must also be entered in its standard age class.
- 5. Kids are goats under one year of age. Goatlings are female Goats over one year and under one and a half years that have not borne a kid. Bucklings are male goats over one year and under two A doe that has slipped or borne a dead kid is regarded as a kidded as a kidded animal.
- 6. All exhibits must lead and tie up.
- 7. Goatlings are not eligible for Champion Doe.

- 8. In group classes all goats in class must be of the same breed.
- 9. No person being a member of the family or an employee of the official judge or the trainee judge shall be entitled to exhibit
- 10. Exhibitors must wear white coats or smocks while parading goats and these may not carry any distinguishing words or emblems.
- 11.In the best udder class points must be allotted for both full and empty udders. The highest total of points shall decide the winner.
- 12. Champion Doe is to be judged with a full udder.

Postal and Online Entries Close 17th January 2025. Late entries may be accepted but there will be a \$20 late entry fee.

Open to all dairy goats in milk, not entered in any of the above classes

#### Class 2010 Best Udder

Open to all in-milk does that have borne a kid.

- to be judged when full and again when stripped out, the points awarded for both full and empty udder to be totaled to determine the prize winner. (Does must be finally stripped prior to entering the ring for the second time)

Class 2011 Dam & daughter

Dam must be in milk however daughter can be of any age and may or may not be in milk

#### Class 2012 Breeding Group

3 does in milk same breed, bona fide property of exhibitor

#### Class 2013 Junior Showperson- aged 15 years and under

Junior showperson to be judged on the exhibitor's ability to lead, place, turn, stop and start their goat. To answer 2 questions. Show preparation and appearance of both exhibitor and goat to be taken into account. Exhibitor's age to be included on entry form. Entry free, Post entries accepted on day.

Class 2014 Junior Showperson - 16 years up to 25 years.

Showing an Adult Goat. To be judged on presentation and knowledge of the anatomy of the animal also the handling and health of the adult goat. The goat does not have to belong to the exhibitor. Entry free. Post entries accepted

- Class 2015 Maiden Doe Goatling, over 12 months and under 30 months Including maiden milkers and springing does.
- Class 2016 Doe Kid, under 12 months of age Junior Champion Standard age Doe Junior Reserve Champion Standard age Doe Junior Reserve Champion doe the second prize winner in the class from which the Junior Champion Doe was selected to be paraded with the other first prize winner.
- Class 2017 Unregistered Doe kid, under 12 months
  - not eligible for championships

- Class 2018 Buck kid, under 12 months of age
- Class 2019 Appendix A Buck kid, under 12 months of age
- Class 2020 Buckling, over 12 months and under 2 years

#### Royal Agricultural Society of NZ - Yellow Card System

The following outlines the recommended rules and implementation of the RAS Yellow Warning Card System.

1. The President of the Show or their duly appointed delegate and/or the Chief Steward of the Section/Stand may issue a yellow warning card instead of fines or other penalties applicable as indicated in the RAS affiliated Show or Event Own Rules and Regulations, to the Person Responsible (PR) – (see definition of PR at conclusion) in the following instances:

i. Abuse of animals in any form as provided for

- a. Equine Rule 52 (RAS Equestrian Competitors & Judges Rule Book & Guidelines) and Article 143 (FEI General Regulations)
- b. Dairy as per the RAS Showing Rules & Regulations for Dairy Cattle.

c. All livestock, including equine & dairy – as per rule 3 under Health & Safety, RAS Showing Rules & Regulations. ii. Inappropriate behaviour towards Show officials, Judges, fellow competitors or any other third party connected with the RAS affiliated Show/Event, including Approved Measuring Stands and their grounds, bringing the A&P movement into disrepute, or cases which are of a less serious nature to the above in accordance with the Conduct of Members, Owners, Lessees, Competitors and/or Exhibitors as provided.

- a. Equine refer to RAS Equestrian Competitors and Judges Rulebook
- b. All Persons Responsible, including equestrian refer to rule 8 under Disruptive or Unacceptable Behavior, RAS Showing Rules or Regulations
- c. Rule 13 of the RAS Constitution. Inappropriate behavior constitutes any behaviour deemed by the President of the Show or their duly appointed delegate and/or the Chief Steward of the Section/Stand involved that brings the A&P movement into disrepute including but not limited to Inappropriate language, swearing, cheating or deliberately attempting to work outside of the generally accepted show rules and protocols. This also extends to inappropriate written communication via Facebook, twitter, text, on-line forums and the like
- 2. A yellow warning card may be delivered to the Person Responsible either by hand, post or by any other suitable means. The Person Responsible may accept or reject the yellow warning card. If the Person Responsible accepts a yellow warning card, no other penalty recorded in the RAS Bylaws or Rules & Regulations will be imposed against the Person Responsible in respect of the actions for which the yellow warning card was issued.
- 3. If a yellow warning card is delivered to the Person Responsible either by hand, post or any other suitable means at the RAS affiliated Show/Event or registered Measuring Stand and their grounds to which the yellow warning card relates and the Person Responsible rejects the yellow warning card, the applicable appeal/discipline procedure recorded in the RAS Complaints Procedure will be instituted.
  - 4. If a yellow warning card is delivered to the Person Responsible after the Show/Event or registered Measuring Stand and their grounds to which the yellow carding card relates, this must be done within 10 days of the event/show/measuring appointment giving rise to the incident.
  - 5. If a yellow warning card is delivered to the Person Responsible after the Show/Event or registered Measuring Stand and their grounds to which the yellow carding card relates, the Person Responsible may only reject the yellow warning card by sending it to the RAS within 48 hours of receipt, in which case the matter will be referred to the relevant Disputes, Protests or Hearing Committee as per the RAS Complaints Procedure.
  - 6. As soon as possible after issuing a yellow warning card, the Show/Event/Measuring Official concerned shall forward details (butt) regarding the issuing of the yellow warning card and the Person Responsible to the RAS Head Office. The RAS will support this by maintaining a register of yellow warning cards and record such details on that register.
  - 7. If a person receives a second yellow warning card at the same or at any other Show/Event/ registered Measuring Stand and their grounds within 12 months of the first yellow warning card being issued to that person, the case shall be submitted to the RAS Hearing Committee for consideration in accordance with the RAS Complaints Procedure. In deciding the penalty to be imposed on the Person Responsible the Hearing Committee will take into consideration whether the offence for which the first yellow warning card was issued is similar to the offence causing the second yellow warning card to be issued to the same person within 12 months of the first.
  - 8. Notwithstanding this warning card system, cases of repetition in the same type of offence within two years from the first offence shall be penalized by up to the maximum penalty foreseen for the offence in question.
  - 9. The implementation and acceptance of the Yellow Card will always entail the disqualification of the animal and PR from the Show/Event and the forfeiture of any prize money won in the same Show/Event if applicable.

#### TIME OF IMPLEMENTATION OF DECISIONS

1. Decisions against which there cannot be an appeal shall be effective from the date of the notification to the persons or bodies concerned. 2. Decisions to which the parties concerned have formally renounced their right of appeal shall become effective on the date when the renunciation reaches the RAS.

3. Decisions taken by President of the Show or their duly appointed delegate and/or the Chief Steward OR Disputes, Protests or Hearing Committee shall be effective from the moment the time limit for lodging an appeal has expired.

February 2013 Definition of Person Responsible – the person actually committing the offence whether it be abuse of animal or inappropriate behavior. In the case of the specific dairy cattle rules, the PR will be as referred to in those rules.
